



# Better Process Canning School - Acidified

This 1-day training will help you meet the licensing requirement for canning acid and acidified foods. Acidified canned foods such as pickles, salsa, and sauces that are manufactured for sale must have a recipe review and critical processing factors identified by a Process Authority. Recipes for other canned foods such as non-standard jams and jellies should be reviewed and important processing factors identified to maintain product safety. This training covers the science and technology behind safe manufacture of canned foods, with a focus on acidified foods. The training will walk processors through the development and approval of a scheduled process. Good Manufacturing Practices will be discussed to help processors be compliant with state and federal regulations. While focused on meeting Wisconsin and FDA requirements, processors from other states are welcome to attend, space permitting. There are 4 open-book exams during the training.
